1. Welcome and introductions: Chair – CRD director John Massier

### 2. P4HC: NC Imagine grant

- Review of 2019 Grant application draft; The school garden proposals from Bouchie Lake
  Elementary and Correlieu Secondary School were reviewed. Most of the information is in
  place, with a final contact with Bouchie Lake Elementary needed. Sue MacNeill noted she
  would like to gain approval from the Senior Advocacy Service to initiate a program where
  seniors assist with school gardens. Tara Johima reviewed the progress on the garden at
  Parkland, noting that the theft of the water tanks from a locked storage shed, are creating
  challenges to start up of the program. Potential proposals for community workshops were
  reviewed, including Kersley and Bouchie Lake.
- Process for finalization and approval Proposals will be sent to Lori by March 25 along with Letters of Support so the March 31<sup>st</sup> deadline can be met.

## 3. Updates P4HC: NC committee members

Senior Advocacy Service: Life after 60 Project is moving forward with a proposed launch in May. The application review process is underway and currently 12 businesses are on board; Cariboo Regional District: The Cariboo Regional District plans to explore opportunities available as it develops its next 10-year solid waste management plan, with the plan development and consultation starting in 2020;

**Quesnel Farmers Market**: The BC Farmers' Market Trail will expand in 2019 to showcase the Cariboo region Farmers Markets;

**Parkland Community Association**: Tara mentioned the Parkland Community Hall may be closed down if the Parkland Recreation Commission does not have the required number of commissioners. Tara is happy to report they now have 10 commissioners for the Rec

Commission, who will go through the orientation program. A public meeting will be held to determine the budget and 5-year plan. A decision will then be made as to the funding of the community hall.

- **4. Progress report to North Cariboo Rural Directors Caucus** is on the agenda for the April 9<sup>th</sup> meeting. Lori will compile the P4HC: NC update and send the letter to committee members for review. The update needs to be sent to the CRD before April 3<sup>rd</sup> to get on the agenda.
- **5. Seedy Saturday April 13 from 10am 3 pm at CNC**; The P4HC: NC booth has been planned and will include a display of the food preservation and storage equipment available in the rural communities as well as demonstrations of food preservation methods and food samples for the public.
