Imagine Grant Proposal through Northern Health Applicant – Growing North Cariboo Society

Name of Event: ParticipAGtion

An activity based event focusing on Foraging and Small Animal Production

Expanding on the Seedy Saturday and Ag & Hort Leap Conference concept this event would be held in late May of 2015 to provide workshops on:

- Small Animal production i.e. rabbits, poultry, bees, sheep
- Foraging for local wild foods and ideas for use i.e. mushrooms, wild berries, dandelions, fiddleheads, birch syrup tapping, beneficial insects, etc.
- Other topics could include Root Cellar building and Farming by Horse.

Workshops would be centred at the College of New Caledonia – Quesnel Campus and Alex Fraser Park and would have a small registration fee.

The focus of this event would be 2-fold. Participants would be provided with physically active workshops related to foraging for food and educational workshops related to increasing food security by providing knowledge on how to supply food by small animal production and foraging for food in the local community. Participants would obtain a pedometer in their registration package and use this to track the amount of walking they achieve as they walk between venues and during the workshops.
