- 1. Welcome and introductions: Designated Chair: Cathy Juric
- 2. Update on P4HC: NC co-chair position Cariboo Regional District; CRD Director John Massier has agreed to co-chair the P4HC-NC committee and this was approved at the CRD meeting on March 23rd. Lori will email Mandy Levesque at Northern Health to let them know and change the Terms of Reference.
- **3.** Empowering Family Health Stream 2 final report due March 31:
 - 2017 Empowering Family Health program evaluation; near completion and will be sent to Northern Health by March 31st. The project went well although there were scheduling changes due to the extreme wildfire season over the summer. There were 119 people in attendance at the workshops and the Baker Creek Community has joined the group as a stakeholder. Group.
 - 2017 Empowering Family Health budget; completed and will be sent to Northern Health with the evaluation. Budget was balanced with a bit remaining at the end so 3 books called The Boreal Herbal were purchased to be gifted to the communities of Kersley, Bouchie Lake, and 10-Mile/Parkland.
- **4.** P4HC: NC 2018 grant application to Northern Health
 - Update on changes to funding stream and quantity of grant; The P4HC funding stream has been incorporated into the Imagine grant funding stream with grant application intakes in the spring and fall for \$5000 each intake.
 - Review of 2018 P4HC: NC grant application for Imagine grant funding; Grant application is near completion and Lori will incorporate the roles and responsibilities of partnering groups and letters of support once received. Grant application should be sent to Northern Health by March 30th.

- Next funding intake in September 2018 Workshops on Cheese making and Garden Box Seed Starting
- Request for Proposals; Lori will review and update the RFP and have it ready for distribution to the EFH distribution list, schools and community associations before May 15. This RFP will be for the September grant intake and will be due Sept. 11.
