- 1. Welcome and introductions: Designated Chair: Cathy Juric
- 2. Empowering Family Health Stream 1 project completion update: We have not received a reply from Northern Health other than approval of the Stream 2 project funding application so we are assuming everything is in order. Heloise is completing the workshop evaluation summary.
- 3. Empowering Family Health Stream 2 progress report:
  - Grant application policy and procedures accounting practices Booklet is complete
    and the information was shared with the Seedy Saturday committee. Cathy and
    Wilma requested they receive a copy by email. Lori will do this. Heloise was
    wondering if a policy on the use of the Northern Health logo needs to be developed.
    She was wondering if blanket approval from NH for the use of their logo for projects
    could be obtained.
  - Facilitator contract begins document was signed by 2 NC P4HC members & facilitator
  - Seedy Saturday evaluation in progress Colleen and Wilma will complete and forward the information to Heloise for the report to be sent to Northern Health
  - Facilitator workshop component update:
    - Heloise contacted Melinda and Sue and is waiting for their reply.
    - Heloise has added email to the EFH group list even requests for information from some out of town. A network is forming across the province.
    - Heloise has laid out the plans for the foraging workshop and is drying those plants that are already past season for demonstration purposes. Some clarification on the location(s) of the foraging workshop.
